

Regular meeting of the mayor and council was held September 15, 2014, 5:00 p.m. at city hall. Mayor Jennifer Brush presided. Council members present: John Cary, Teri Cordill, Jerry Knouf, David Draayer, David Hardy. Others present: Terry Gradig, Ron Duran, Vickie Oviatt, LaRhea Cole, Cathy Shellito.

Mayor Brush called the meeting to order and led in the flag salute.

Jerry moved, seconded by Teri, to approve the minutes of the September 2, 2014 meeting as presented. Carried.

Jerry gave the law enforcement activity report for the period of August 1 – September 1, 2014.

Ron Duran reported that the veterinary clinic had requested a form be provided for their use in order to release animals after city office hours. Council reviewed the form prepared in the city office. Mayor Brush noted that this would help with a paper trail of impounds. Council agreed and approved the form.

Dave Hardy entered.

Teri asked Ron how to get ahold of him if the city office is closed. Ron said to call his house phone.

City Superintendent presented an updated copy of the Engineer's Estimate of Cost on the 181-71 KA-3048-01 geometric project. The total project cost is \$716,853.00 with the city match at \$16,853.00.

Terry reported that they have been working at the lagoons moving dirt so it will drain properly. Terry will check with KDHE before allowing Dale Goheen to plant and harvest wheat at the lagoons.

The city crew has been mowing, street sweeping, and will possibly spray for mosquitoes if needed.

Teri asked about the responsibility of the alleys. Terry said that alleys are the homeowner's responsibility.

Mayor Brush reported that Janice Boland, Osborne County EMT Director, will attend the meeting in October.

Council approved for Mayor Brush to prepare a city promotional page to be included in the Chamber's coupon book, at no charge to the city.

John moved, seconded by Dave H., to approve a license to transport solid waste, #14-61. Carried.

Jerry moved, seconded by John, to approve building permit #14-20. Carried.

Dave H. moved, seconded by Teri, to approve building permit #14-21. Carried.

An ordinance requiring scrap metal dealers to be licensed was reviewed. Action was tabled.

Mayor Brush noted that Schwab-Eaton would be surveying the old tree dump area later in the week.

John moved, seconded by Teri, to waive the memorial hall fees for the Nu Alpha sponsored kid's Halloween parade on Monday, October 27, 2014. Carried.

Vouchers were reviewed and signed. Dave D. moved, seconded by Jerry, to approve the vouchers/payroll as presented. Carried.

Dave D. moved, seconded by Dave H., to adjourn at 5:37 p.m. Carried. Meeting adjourned.
