The Neighborhood Exterior Maintenance Program intends to assist Downs homeowners in maintaining and reinvesting in their properties. The program awards funds to assist with actual costs incurred by a homeowner for materials, construction and/or architectural services to perform and complete eligible exterior improvements.

#### **How Does It Work?**

The Neighborhood Maintenance Program reimburses homeowners up to \$1,000 for the purpose of materials and equipment rentals required to renovate the exterior of their property. This program is operated on a first-come, first-serve basis and funding priority will be given to structures in the greatest need of revitalization. Applicants are only allowed to apply for the program on one property, one time per year.

### **How Do I Apply to Participate in the Program?**

Submit a "before" picture of your property along with your completed application form. You will get notified either of approval or denial within 30 days. If you are approved to participate, you will then have 90 days to get your revitalization project completed. Applications will not be accepted for projects that are already completed or currently in progress. Applicants are encouraged to purchase their materials in Downs or Osborne County.

### **How Do I Receive My Funds?**

Approved program participants must submit an "after" picture of their revitalization project along with itemized receipt(s) for materials and equipment rentals within 30 days of project completion to be reimbursed.

#### What Exterior Improvements Are Allowed?

Eligible improvements include exterior painting, siding replacement, windows, doors, gutters, roof repair/replacement, landscaping revitalization, driveway repair, patio or deck repair/replacement, sidewalk repair, etc. All projects MUST be exterior, and visible to those passing by.

#### I Own Rental Property – Can I Still Apply?

If you own rental property, you can apply to participate in the program. However, you will only be able to make improvements to one property per year, including personal property under the program.

#### Can I Do the Work Myself OR Do I Need to Hire a Licensed Contractor?

You do not need to use a contractor to complete this work, provided that the revitalization project is done to a satisfactory standard. However, labor costs will only be reimbursed for professional contractors who are licensed with the City of Downs. Applicants are required to follow all city codes, ordinances, and regulations in relation to the revitalization project.

#### **How Much Funding Is Available?**

The Neighborhood Exterior Maintenance Program will reimburse projects as funds allow. Applications not approved due to the depletion of funding allocations, will be reconsidered the following calendar year. Applicants are encouraged to reapply.
